1.0 DEFINITION

In this licence, unless stated otherwise or the context otherwise requires:-

- 1.1.1 "Acts" means the Tanzania Communications Regulatory Authority Act No.12 of 2003, Tanzania Communications Act No.18 of 1993 and Broadcasting Services Act No.6 of 1993.
- 1.1.2 "Application Services" form of services provided to the end users using network service providers.
- 1.1.3 "Authority" means the Tanzania Communications Regulatory Authority
- 1.1.4 "Licence" means authority to provide application services
- 1.1.5 "Licensee" means any person holding this licence
- 1.1.6 "Licence Period" means the duration of the validity of the licence
- 1.1.7 "Application fee" – means fee paid by an applicant when applying for licence.
- 1.1.8 "Licence fee - means a fee paid to the Authority for operating the license.
- 1.1.9 "Royalty" means charge paid by a licensee for a right of providing licensed services.
- 1.1.10 "Initial Licence Fee" means non recurrent upfront fee paid to the Authority for the grant of the licence
- 1.1.11 "Minister" means the Minister responsible for electronic communications

2.0 SCOPE OF THE LICENCE

- 2.1. The Tanzania Communications Regulatory Authority in accordance with Section 6 of the Tanzania Communications Regulatory Authority Act, 2003 and Section 11 of the Tanzania Communications Act, 1993 hereby grants a licence to ..... to provide applications services
- 2.2. Licensee is authorized to operate in ..... (area) and provide .....(Applications Services)

3.0 DURATION OF THE LICENCE

This licence is granted on ..... (the Effective Date) for a period of 5 (five years) ("the licence period").

4.0 RENEWAL OF THE LICENCE

- 4.1 The Authority shall renew the licence in accordance with the Tanzania Communications Regulatory Authority Act, 2003.
- 4.2 Six months prior to the expiry of the licence period, the Licensee shall apply to the Authority for the renewal of this licence in accordance with the applicable provisions of the Acts and regulations.
- 4.3 The Licence shall terminate upon expiry of the licence period if not renewed.

**5.0 OWNERSHIP AND CORPORATE OBLIGATION**

The Licensee shall comply with the following conditions on ownership:-

- 5.1 to furnish the Authority a copy of their shareholding structure as required by the Communication Licensing Regulations
- 5.2 to notify the Authority in writing of any changes to its ownership and control structure.
- 5.3 to notify the Authority of any joint venture into which it enters with any other person or entity holding a licence issued by the Authority.

**6.0 LICENCE FEES**

- 6.1 The Licence Fees in respect of this Licence and its renewal shall be as determined by the Authority.
- 6.2 In addition to any licence application fee paid by the Licensee, the Licensee, shall pay to the Authority:
  - 5.2.1 Initial Licence Fee .....
  - 5.2.2 Annual Fee.....
  - 5.2.3 Royalty .....
  - 5.2.4 The Royalty shall be paid quarterly in arrears. Any Royalty delayed for more than thirty (30) days shall attract an interest at prevailing official Bank lending rate.

**8.0 COMPLIANCE WITH THE LAW**

The Licensee shall comply with the provision of the Acts and other laws of the United Republic of Tanzania.

**9.0 COMPLIANCE WITH REGULATORY REQUIREMENTS**

The Licensee shall comply with the provision of the Authority regulations and rules issued under the Act.

**10.0 PERFORMANCE GUARANTEE**

- 10.1 The Licensee shall guarantee performance of the terms and conditions of the licence and shall execute a guarantee in favour of the Authority subject to performance bank guarantee/performance bond requirement under the Licensing Regulations, 2005.

10.2 A Performance Bank Guarantee/Performance Bond of Us \$ .....being
