1. This Invitation for Tenders follows the General Procurement Notice(GPN) that appeared in the Daily News of 12th August, 2009 Issue No.24455.
2. Tanzania Communications Regulatory Authority (TCRA) has set aside funds in its 2009/2010 budget for its operations. It is intended that part of the funds will be used to meet eligible payments under the contract for Supply, Installation and Commissioning of WAN & VPN.
3. Tanzania Communications Regulatory Authority [TCRA] now invites sealed Tenders from eligible Suppliers of WAN and VPN.
4. Tendering will be conducted through **National Competitive Tendering** a procedure specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2005 – Government Notice No. 97 and is open to all tenderers as defined in the Regulations.
5. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary, TCRA Tender Board, Tanzania Communications Regulatory Authority, Mwasiliano Towers, Sam Nujoma Road, Sinza. P.O Box 474 Dar Es Salaam from 9:00am to 3.00pm on Mondays to Fridays inclusive, except on Public Holidays.

A complete set of the Tendering Documents and additional sets in English may be purchased by interested Tenderers upon submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of TZS 100,000/= (Tanzanian Shillings One Hundred Thousand Only). Payment should be made either by cash, Banker's Draft or Banker's Cheque, payable to Tanzania Communications Regulatory Authority.
7. All Tenders must be accompanied by a Tender security in an acceptable form in the amount of One million (1,000,000.00) Tanzanian Shillings of or in freely convertible currency.
8. All tenders in one original plus two copies properly filled in, and enclosed in plain envelopes must be delivered to the address below at or before 11.00 am on Tuesday 6th April, 2010. The outer cover shall be clearly marked '**TENDER NO.AE- 020/2009-10/N/06 SUPPLY, INSTALLATION AND COMMISSIONING OF WAN & VPN**'. Tenders will be opened promptly thereafter in public and in presence of Tenderers or their representatives who choose to attend in the opening at TCRA conference room, Mwasiliano Towers, Sam Nujoma Road-Sinza P.O. Box 474, Dar Es Salaam.
9. Late Tenders, portion of Tenders, Electronic Tenders, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
