# THE ELECTRONIC AND POSTAL COMMUNICATIONS (DOMAIN NAMES MANAGEMENT) (AMENDMENT) REGULATIONS, 2023

Citation 1. These Regulations may be cited as the Electronic and Postal Communications (Domain Names Management) (Amendment) Regulations, 2023, and shall GN No. be read as one with the Electronic and Postal 940 of 2020 (Domain Names Management) Communications Regulations, 2020 hereinafter referred to as the "principal Regulations". Amendment of 2. The principal Regulations are amended in regulation 3 regulation 3(1) by deleting the words "which requires domain name" appearing between the words "Tanzania" and "shall", substituting for them the words "which has an internet presence". Amendment of 3. The principal Regulations are amended in regulation 4 regulation 4(1) by deleting paragraph (a) and substituting for it the following: "(a) apply to the Authority by-(i) filling in an application form set out in the First Schedule; and (ii) paying non-refundable а application fee prescribed in the Second Schedule;". Addition of 4. The principal Regulations are amended by

regulation 4A	adding immediately after regulation 4 the following:

"Accreditation 4A.-(1) The accreditation period shall be one year from the date of issue of the accreditation certification. (2) The accredited registrar shall

(2) The accredited registral shall notify the Authority of its intention to renew the accreditation certificate at least one month before the expiration date of such certificate."

Amendment of regulation 6

- of 5. The principal Regulations are amended in regulation 6 by-
  - (a) deleting the word "or" appearing at the end of paragraph (a);
  - (b) deleting full stop appearing at the end of paragraph (b) and substituting for it the word "; or";
  - (c) adding immediately after paragraph (b) the following:

"(c) fails to meet key performance indicators prescribed in the accreditation certificate.".

Amendment of regulation 7

6. The principal Regulations are amended in regulation 7 by-

- (a) deleting the word "or" appearing at the end of paragraph (b);
- (b) deleting full stop appearing at the end of paragraph (c) and substituting for it the word "; or";
- (c) adding immediately after paragraph (c) the following:

"(d) fails to meet key performance indicators prescribed in the accreditation certificate.".

Addition of regulation 10A

7. The principal Regulations are amended by

adding immediately after regulation 10 the following:

and	"Reservation auctioning of domain
names	

10A.-(1) The Authority shall prepare and publish on the Authority's website a list of reserved domain names including government names, international internet bodies names, one character names, and two characters names.".

(2) The Authority shall have powers to auction the reserved one character domain names and two character domains names.".

Amendment of regulation 14

8. The principal Regulations are amended in regulation 14 by-

- (a) deleting a full stop appearing at the end of paragraph (d) and substituting for it a semicolon;
- (b) adding immediately after paragraph (d) the following:

"(e) when providing registration services, collect regulatory fees on behalf of the Authority as provided under the Second Schedule:

(f) pay the fee prescribed in the Second Schedule in respect of registration services rendered;

(g) ensuring that the information and data provided to the registrar by a customer are submitted to the Authority in a complete and accurate manner, and make all reasonable efforts to verify such information and

make the customer aware of the consequences of submitting false

information and data;

(h) upon request by the Authority, submit within time prescribed in the notice or in any case not later than fourteen (14) days of receiving such a request, documents

that can be used to verify the completeness and accuracy of the submitted customer information or data; and (i) process personal data of persons kept in the Central Registry in compliance with the laws governing personal data processing.".

Amendment of regulation 20

9. The principal Regulations are amended in regulation 20 by adding immediately after sub regulation (4) the following:

"(5) Members of the Technical Advisory Committee shall serve for a term of two years from the date of appointment, and may be eligible for reappointment for one further term."

Amendment of First Schedule. 10. The principal Regulations are amended in the First Schedule by-
