**Invitation for Tenders**

1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in the **Public Procurement Regulatory Authority (PPRA) portal of 1<sup>st</sup> July, 2019**
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the Tanzania Communications Regulatory Authority during the financial year 2019/2020. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Design, Supply, Install, and Configure, Test and Commission Radio Frequency and Broadcasting Equipment type approval testing laboratories.
3. The Tanzania Communications Regulatory Authority (TCRA) now invites Tenders from eligible Manufacturers/dealers for Design, Supply, Install, and Configure, Test and Commission Radio Frequency and Broadcasting Equipment type approval testing laboratories.
4. There are two (2) Lots in this Tender namely:-
  - (i) **Lot 1:** Design, Supply, Install, and Configure, Test and Commission of Broadcasting Equipment Testing Laboratory
  - (ii) **Lot 2:** Design, Supply, Install, and Configure, Test and Commission Radio Frequency (RF) Testing Laboratory

**Manufacturers/dealers are allowed to quote one Lot or all Lots but must quote for all ITEMS in that particular Lot.**

5. Tendering will be conducted through the **International Competitive Bidding** procedures specified in the Public Procurement Regulations, 2013–Government Notice No. 446 as amended in 2016, and is open to all Tenderers as defined in the Regulations.
6. Interested eligible Tenders may obtain further information from and inspect the Tendering Documents at the office of the **Head of Procurement Management Unit, 5<sup>th</sup> Floor, Room 511 ,TCRA Headquarters , located at Sam Nujoma Road, Mawasiliano Towers; Dar Es Salaam from 08.00 a.m. to 4.00 p.m on Mondays to Friday**, inclusive, except on public holidays.
7. A complete set of Tendering Document(s) in **English Language** and additional sets may be purchased by interested tenderers through the portal and upon payment of a non-refundable participation fee of **TZS. 30,000.00**. Payments to be done through the dedicated payment gateway integrated in the TANEPS.
8. All Tenders must be accompanied by a Tender security in an acceptable form for **TZS 25,000,000.00** or any freely convertible currencies.
9. All Tenders must be electronically submitted in the proper format, at or before **Thursday, 15<sup>th</sup> May, 2020** tenders will be opened promptly thereafter in public and in the presence of Bidder's Representative who choose to attend in opening at Mawasiliano Tower 20 Sam Nujoma Roads, P.O. Box 474,14414 Dar-Es-Salaam.
